
2017 Annual Report





Fellow South Carolinians,

Palmetto Care Connections (PCC) had another amazing year in 2017! We are so fortunate to have the continued support and commitment from our Board of Directors as well as our Advisory Council as our team has worked diligently to improve access to quality health care services in our rural/underserved communities across the state through the use of telehealth. We have continued to forge new partnerships and collaborations while never forgetting our original and founding partners and this has allowed us to grow telehealth throughout South Carolina. PCC is very fortunate to have added two new extraordinary professionals to the Board of Directors. We welcome both Rich Rogers, Chief Information Officer for Greenville Health System, and Dr. Mark Williams, Chief Clinical Officer for Palmetto Health. We would also like to welcome our newest member to the PCC team, Ms. Joni Brown who serves as our Technical Analyst. We are very lucky to have our newest additions.

PCC has worked very closely with the South Carolina Telehealth Alliance (SCTA) this year to ensure that the 2017 Statewide Telehealth Strategic Plan goals/objectives were met. We again partnered with SCTA to develop a new 2018 Statewide Telehealth Strategic Plan which included two new Strategies focusing on telehealth outcomes and the expansion of mental health and addictive disease telehealth clinical services. PCC has also worked diligently to expand broadband services into rural/underserved communities because adequate bandwidth is a necessity when it comes to conducting telehealth visits. In 2017, PCC was able to expand the Palmetto State Providers Network (PSPN), SC's Broadband Consortium, from approximately 100 circuits to over 300 circuits, saving health care providers in SC more than \$3.4million dollars in connectivity costs over a three-year period of time. Another tremendous accomplishment came with working with the Alcohol & Drug Abuse Centers in SC as we partnered with the Behavioral Health Services Administration (BHSA) to install telehealth carts in about half of their 46 centers across the state.

Let's all work together a little more collaboratively, a little more eagerly, a little more enthusiastically and a little more supportively to make sure telehealth reaches into all of our communities across South Carolina. If we commit to this challenge now then 2018 will prove to be an even better year for our great state and the amazing people that call South Carolina home!

Expanded the Palmetto State Providers Network (PSPN), Broadband Consortium for South Carolina, from 120 sites in 2016 to more than 250 sites in 2017.



Awarded a 1.5 year funding commitment from USAC through the Health Care Connect Fund for a total of \$1,865,507 which will save health care providers in South Carolina approximately \$910,000 over 1.5 years.

USAC RFP Approved Approved by USAC to post a Request for Funding (RFP) to all telecommunication service providers in South Carolina for the purpose of increaseing the number of Evergreen Contracts and offering more opportunities for health care providers to participate in PSPN allowing them the opportunity to receive federal funding for their broadband costs.

Co-sponsored the first Regional Telehealth Meeting in Florence, SC, with McLeod Health. Over 50 Florence Area Health Care Professionals attended the one day event to learn more about telehealth activities in their area as well as across the state.

for Telehealth

Led the efforts of the South Carolina Credentialing Workgroup and created a 12 month Pilot Project whereby a central database comprised of telehealth providers in the state will be created allowing spoke hospital to utilize the JCAHO approved Credentialing by Proxy process to credential their telehealth providers thus reducing or eliminating one of their barriers to utilizing telehealth services.

Cost Savings In August 2017, PCC signed a contract with ADP, a Professional Employer Organization, for the purpose of outsourcing payroll, benefits, human resources and risk/safety management services. PCC is projected to save more than \$10,000/year in administrative costs while employees will save approximately \$5,400/year for family health coverage and \$1,800/year on employee only costs.



PROGRAM DEVELOPMENT

Increase the number of primary care and related-care providers with access to mental health and related clinical Broaden mental health services and programs.

Increase the number of rural hospitals with access to mental health and related clinical services and programs.

Broaden mental health and related telehealth clinical services and programs to increase access to care.

Evaluate the feasibility of coordinated, interfacing, bi-directional medical information sharing.

Evaluate the feasibility of a Health Information Exchange program to support the role of a centralized information sharing repository.

In five years, the SCTA –under the leadership of SCDMH—will extensively increase access to mental health and related clinical services and programs via telehealth across South Carolina. Building on existing services and programs, the SCTA will identify and bridge service gaps and diversify the types of mental health and related clinical services and programs available to South Carolinians. Through its unified efforts, the SCTA will integrate and align the state's efforts on telepsychiatry and mental health, emphasizing both (a) the continuum of care for mental health and related clinical services and programs and (b) care across the lifespan of a patient. PCC will assist SCDMH in meeting the goals and objectives for increasing mental health services by Co-Championing several of the tactics as laid out in Strategy 4 in the Statewide Telehealth Strategic Plan.





PCC, in partnership with MUSC, installed telehealth carts in the Bamberg School District II schools, (located in Denmark), Bamberg School District I schools (located in Bamberg) as well as the Williston School District (located in Williston) in the summer of 2017. We have successfully engaged local providers in the Bamberg, Barnwell and Orangeburg communities who will provide the telehealth consults in the schools.

PROGRAM DEVELOPMENT

PCC Awarded RHND Grant for \$896,000



A project of Palmetto Care Connections (PCC), the South Carolina Behavioral Health Network's (SCBHN) purpose is to improve health care access and coordination for rural South Carolinians, reduce the prevalence of opioid addiction, and improve population health, especially as it applies to chronic disease including mental health disorders.

Program Goals

- 1) linking substance abuse and behavioral health providers in 23 South Carolina counties with primary care providers
- 2) creating universal policies, procedures, and workflows for integrating behavioral health and primary care services via telehealth
- 3) creating a centralized scheduling system for network members
- 4) providing training to providers on best practices on telehealth and telepresenting
- 5) connecting members and participating sites to a health information exchange

Palmetto Care Connections (PCC, especially Matt Hiatt, has been especially helpful in the securing and installing of telehealth equipment for the 32 local alcohol and drug abuse authorities in SC that are part of the Behavioral Health Services Association of SC. Our system is very fortunate to have such a strong partner in PCC, to assist the agencies with the equipment installation and set-up, but also with securing HIPAA compliant broadband to ensure a seamless electronic visit. We are confident this partnership will improve quality service delivery, thereby improving the health of the citizens of South Carolina.

Palmetto Care Connections hosted its first Telehealth Regional Meeting in the Pee Dee on October 17, 2017 at the McLeod Plaza Auditorium.



The Palmetto Care Connections Pee Dee Area Regional Meeting was an outstanding event bringing together healthcare professionals working in telehealth as well as those interested in exploring telehealth opportunities in their own workplace. The event was well attended by a variety of health care professionals. Physicians, practitioners, administrative and support personnel who couldn't juggle attending the annual summit in Columbia were able to gain the telehealth education they needed close to home. We look forward to the next event.

ADVOCACY

Little River Medical Center Awarded USDA RUS Grant PCC partnered with an FQHC, Little River Medical Center, to develop a USDA Distance Learning & Telemedicine grant. USDA awarded Little River Medical Center \$418,184 to establish a telemedicine network for a school based primary care initiative in Horry County elementary schools.

Behavioral Health Sites Can Bill Medicaid for Telehealth Services In 2016, PCC along with Mike Dennis, Executive Director for Tri-County Commission on Alcohol & Substance Abuse, met with SC DHHS staff to discuss their desire to become more efficient and provide services via telehealth if they could receive Medicaid reimbursement for the services. The SCBHA sites in partnership with PCC and SCTA worked diligently to advocate for this reimbursement. SC DHHS began reimbursing for these telehealth services in January 2018.

PCC and SCTA partnered to develop a Position Paper and a template for the APRN Telemedicine Protocol Approval Process It was the joint opinion of the SC Board of Nursing and the SC Board of Medical Examiners that neither the Nurse Practice Act, set forth in Chapter 33 of Title 40, nor the Telemedicine Act authorized telenursing. A legislative proviso was established to allow nurse practitioners to deliver services via telehealth: Proviso 117.135 (C). APRNs wishing to provide care via telehealth were required to submit an initial request to the Joint APRN Committee for approval to provide services via telehealth.

Statewide Centralized Centralized Credentialing Project Under the leadership of PCC, the SCTA Credentialing Workgroup developed a model for centralized provider credentialing which will be piloted in 2018. The program will use the Credentialing By Proxy model as the means to streamline the credentialing process for spoke hospitals, and the major telehealth hubs have agreed to create one universal by proxy contract that will be used by all five systems (GHS, MUSC, PH, McLeod, SCDMH).

PCC is an organization that truly understands rural practices. They live rural, work rural, and advocate for rural every day. PCC's efforts have directly led to increased broadband and other investments to further telehealth in rural practices in our state.
