From the Executive's Desk

Fellow South Carolinians,

What an amazing year 2018 turned out to be for telehealth! The continued growth across South Carolina and across the entire nation has been unbelievable. Throughout 2018, we witnessed shifts in state and federal policies, consumer giants like Apple and Samsung pioneered new ways to change the world with telehealth while Congress passed the CHRONIC Care Act, which opens the door for elderly Americans to benefit from telehealth in their home (FINALLY). Tele-MAT was successfully implemented in several behavioral health sites across South Carolina making it easier for Opioid addicts to receive much needed services. We watched several federally qualified health centers in South Carolina step up to the plate and provide telehealth services in the schools and behavioral health facilities. The term broadband hit center stage as health care providers and state leaders identified the need for high-quality broadband access to facilitate telehealth expansion.

In South Carolina, school based telehealth is now available in eighteen schools, direct to consumer virtual care is offered by all of our health systems, tele-psychiatry and tele-mental services have been expanded into our rural communities by the SC Department of Mental Health, and we now have more than 400 broadband circuits for health care providers being funded through the FCC's Health Connect Fund program.

Palmetto Care Connections is proud of our partnership with SCTA as we work diligently to ensure that rural South Carolinians also have access to quality health care services. Collaboration is the key to expanding telehealth in our great state and we here in South Carolina do that very well. We look forward to what 2019 holds for both telehealth and broadband growth and we ask you to look back with us as we take a look at the 2018 accomplishments in this Annual Report.

Bamberg County is a small, economically depressed community and our local schools are one of the biggest assets that we have. Our parents in Bamberg are like parents anywhere...they want the best for their kids. Unfortunately, many of our families have no health insurance, no means of transportation and no extra money for meals if they did have the means to travel to other areas for health care. Telehealth in our schools has allowed our students to be seen in the school by a local physician, Dr. McAlhaney. The technology is utterly amazing to me...you can use the equipment to hear the heartbeat, look down the throat or in the ears of the student. We basically have everything in the schools that is needed to provide health care to our kids except for the physician herself! Our parents have been very receptive to the change and in many cases Dr. McAlhaney is the child's primary care physician. We have all made the choice to live in this community as this is our home. You need to make the place where you live as good as it can be, and telehealth helps us to do just that.

One of the reasons I came back to this area after medical school was that my husband wanted to return to farming, which is his first love. When I came to Bamberg over 20 years ago, the Bamberg County Hospital was financially viable, and in fact it was a bustling hospital. Over the years the number of inpatients declined, and what we found was that technologies in medicine had expanded so much and so quickly that it was difficult for small hospitals to keep up. Our community hospital closed in 2012, leaving a void in specialized care. Our practice was one of the first to do a telemedicine visit with MUSC physicians in tele-psych. It's hard to find psychiatrists in the area to refer patients to. So by having the ability to use MUSC and the tele-psych program, we've been able to provide that service to our patients locally.

Program Development

\$75,000 Grant Award



PCC and its partner S.C. Department of Health & Environmental Control, Division of Healthy Aging, received a \$75,000, five-year grant from the Centers of Disease Control and Prevention, Division of Diabetes and Heart Disease Management in September 2018. The grant helps fund new telehealth and telemedicine applications to connect members and healthcare systems, and health information technology for monitoring patient outcomes. The program will allow providers to review results and make necessary changes in a timely manner to keep patient on track for quality care.

Carolina Ear, Nose, & Throat Clinic



PCC assisted Carolina Ear, Nose & Throat Clinic, P.A. specialist, John F. Ansley, MD with connecting his practice to multiple primary care practices for telehealth consults. PCC assisted with procuring and connecting equipment, implementing telehealth policies and procedures, workflow and staff training.

Eau Claire Cooperative Health Center



Eau Claire Cooperative Health Center (ECCHC) serves the primary health care needs in the Eau Claire community, Columbia, South Carolina's largest underserved collection of low-income neighborhoods. In 2018, PCC assisted ECCHC with identifying, purchasing, and installing telehealth equipment and training staff to connect eight practices in the Midlands, Pee Dee and the Low Country regions so that providers could collaborate on primary care, HIV/AIDS and behavioral health patients.

Little River Medical Center



Over the course of 2018, Palmetto Care Connections partnered with Little River Medical Center (LRMC) to procure the correct hardware and make plans for the deployment of 18 Telehealth carts in and around the Little River and Myrtle Beach areas. LRMC is using the carts for Telehealth between clinics to help with provider shortages and decrease travel time. Additionally, they deployed into several surrounding schools, and are providing primary care and mental health in those schools.



PCC has been an invaluable partner in our Telehealth implementation. PCC was there with advice pre and post purchase, aided in installation, along with training of staff on how to use and troubleshoot minor issues. Additionally, the cost savings through the PSPN broadband consortium lead by PCC has been a great savings that has allowed for investment in other areas, ultimately leading to better care for our patients.

Advocacy & Collaboration

Conference and Meeting Presentations



Palmetto Care Connections (PCC) was invited to share information about telehealth and its impact on health care access at multiple conferences and meetings, including the Legislative Opioid Study Prevention Committee Meeting in 2018. PCC has presented other topics such as "Telehealth in South Carolina," "Marketing Your Telehealth Program," "Telehealth and Broadband," and more.

Centralized Credentialing Initiative



Led by Palmetto Care Connections (PCC), work on the centralized credentialing pilot continued throughout 2018. The goal of this pilot is to test a model for streamlined credentialing for spoke hospitals using a common database and a Credentialing By Proxy process. The database was finalized and shared with the pilot team in August, and all of SC Department of Mental Health's telepsychiatry providers were manually added to the database. Beaufort Memorial Hospital agreed to be the first spoke hospital to pilot the use of the database, and MUSC is preparing to pilot the database with its telestroke providers in CY19. As this pilot progresses and PCC receives feedback from spoke hospitals, the workgroup will assess the overall feasibility and sustainability of this model.

New Partnerships

New partnerships have been established with the Center for Telehealth and eHealth Law (CTeL), Ohio Valley Physicians, South Carolina Behavioral Health Services Administration, South Carolina Institute of Medicine and Public Health, and the School, Health Care, Library and Broadband Coalition (SHLB).
