As the Chair of the Board of Directors for Palmetto Care Connections (PCC), I am pleased and honored to share the 2022 Annual Report. I am proud to have supported and witnessed PCC's dedication to increase access to care through telehealth, technology, and broadband at the forefront of the covid-19 pandemic. PCC has promoted and provided telehealth support services to health care providers serving rural and underserved communities for twelve years.

In its vision to increase access to care through telehealth utilization, PCC soon recognized the significant role of broadband with the utilization of telehealth. In 2015, PCC became the Broadband Consortium Leader for South Carolina assisting hospitals, federally qualified health centers, skilled nursing facilities, rural health clinics, behavioral health clinics and other eligible

healthcare provide in saving millions of dollars on broadband expenses. PCC diligently worked to help healthcare providers become "telehealth ready" to connect with their patients. During the covid-19 pandemic, it was discovered that while most healthcare providers were "telehealth ready", their patients were not. PCC expanded its services to the patient community by connecting the unconnected with the launch of its digital inclusion program and creating telehealth access points in settings such as churches, senior centers, and affordable housing developments.

PCC continues to demonstrate its devotion to increase access to healthcare in rural and underserved areas through telehealth, technology, and broadband by convening with its partners and developing new relationships with community-based organizations to catalyze health equity in South Carolina. This Annual Report will reflect PCC's commitment to health equity and its trailblazer mindset to take innovative approaches to connect the provider to the patient and the patient to the provider.

letter from the chief executive officer

What a busy and wonderful year this has been for Palmetto Care Connections (PCC) striving towards digital and health equity through the use of broadband, telehealth, and technology since COVID-19! On the journey to increase telehealth adoption in South Carolina, PCC has developed a focus on infrastructure, education, training, and digital skills.

*I am proud to share the impact of PCC's Broadband Consortium statewide and nationally. Since 2013, PCC has saved healthcare providers in South Carolina more than **\$42 million** in broadband costs. Nationwide, PCC has saved eligible healthcare providers more than **\$74 million** in broadband costs.*

*Telehealth education through webinars and the Annual Telehealth Summit continues to be a priority at PCC. We were finally back in person at our 10th Annual Telehealth Summit, and it was amazing! The Summit showcased a legislative panel, payer panel, and other diverse sessions that were supportive of telehealth and broadband to reach **250 registrants and 26 sponsors**. As co-chair of the South Carolina Telehealth Alliance (SCTA), PCC and SCTA collaborate to provide telehealth education and implementation support across the state. During Telehealth Awareness Week, together SCTA and PCC covered advocacy and outreach on all levels with legislators, state agencies, community-based organizations, clinicians, and patients.*

*During the covid-19 pandemic, telehealth adoption by healthcare providers grew at an exponential rate. A moment of feeling accomplished faded as we began to realize the needs of the patient for infrastructure, education, training, and digital skills to improve telehealth adoption. PCC seized the opportunity to close the gap by launching its digital inclusion program. Through our digital inclusion program, PCC has reached nearly **1,000 South Carolinians** in rural and underserved communities in **13 Counties** and counting! Each program participant received in person digital literacy training with a telehealth segment, a laptop or tablet, and assistance with affordable internet solutions. Through digital inclusion, PCC tapped into an even more aggressive grassroots level and actually touched the patient. We are truly honored to have worked with these amazing individuals over the last year. This would not have been possible without the support of our funding partners and community-based organizations.*

I am honored to share the hard work of our PCC staff and partners that was accomplished in 2022. We look forward to working with partners, community leaders, and our Board of Directors in 2023 to continue to address telehealth, and healthcare access in our rural and underserved populations.

CareSouth Carolina presented Palmetto Care Connections with its Partnership Award. Palmetto Care Connections provides broadband and telehealth support services to CareSouth Carolina, Inc.

Connected Care Pilot Grant

The Federal Communications Commission (FCC) Connected Care Pilot Program awarded \$7,199,892 to the broadband consortium of South Carolina, formerly known as the Palmetto State Providers Network (PSPN) led by Palmetto Care Connections. The funding will enable five federally qualified health centers and one hospital system to provide broadband internet access services, remote patient monitoring, and video consults to 5,000 primarily low-income South Carolinians suffering from chronic conditions and infectious diseases. In addition, the funding will provide health care provider broadband data connections, a connected care telehealth platform and data analytics to facilitate synchronous telehealth services for an estimated 18,000 patients in 13 counties.

- **57,125 qualifying patients will gain access to internet services to better control their healthcare outcomes**
- **Consortium members serve a predominantly rural and underserved population that includes veterans and low income households**
- **Some of the providers in this program exceed 95% of their patient volumes living below the 135% poverty level**

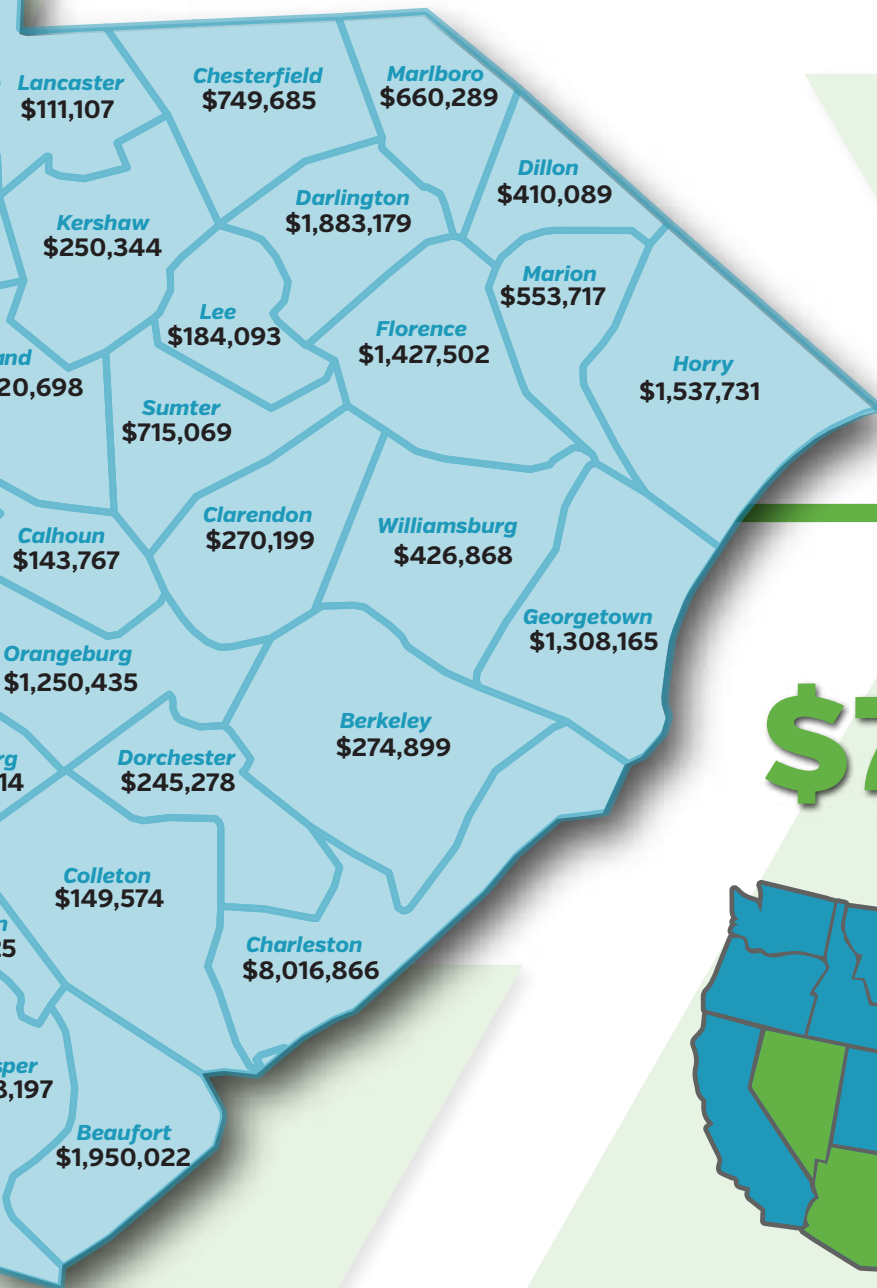

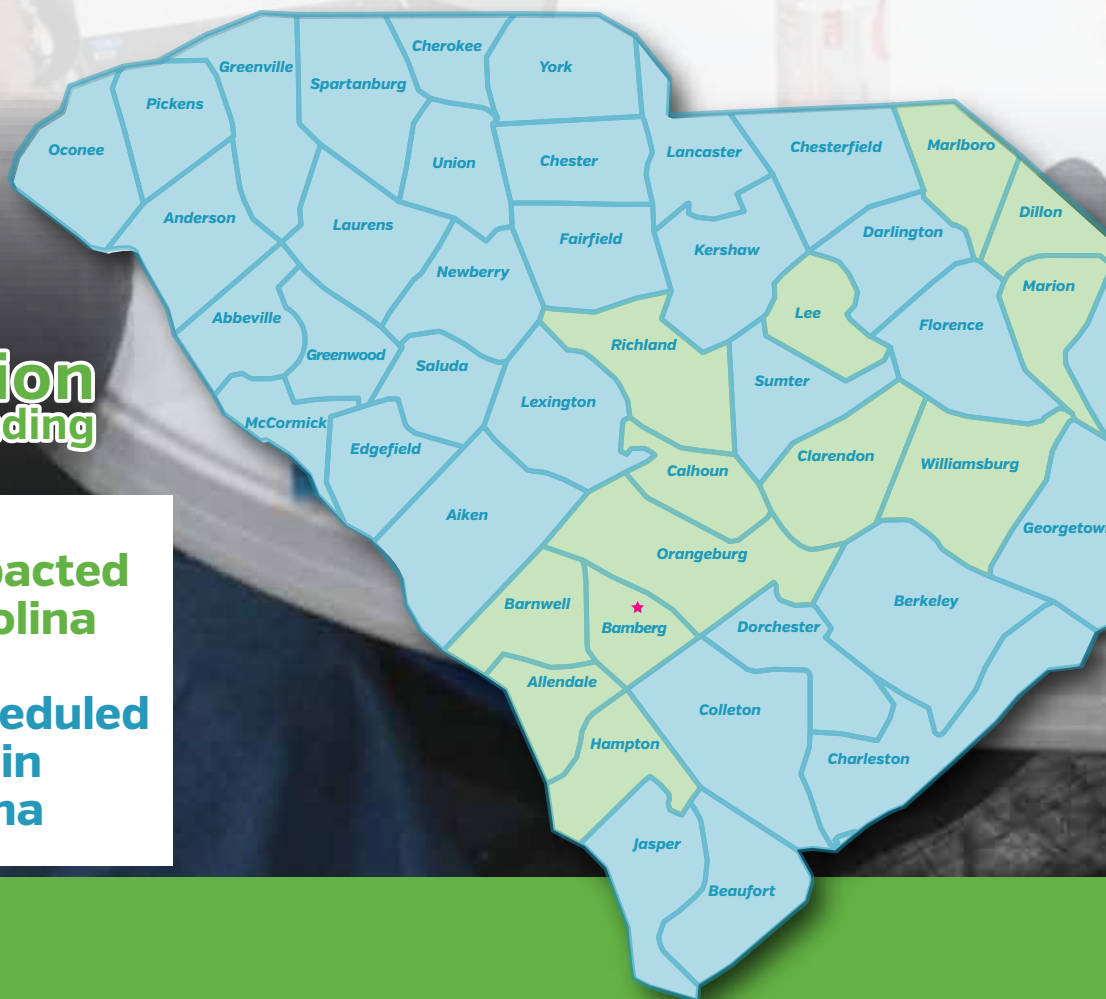

Digital skills are essential for students today to complete homework assignments, communicate with instructors, take tests, and more. Marion County Adult Education (MCAE) assists individuals with attaining their GED (General Educational Development) high school diploma completion, and job training. The collaboration between MCAE and Palmetto Care Connections (PCC) was the perfect solution to a problem presented to Candyce Brooks, Director of Marion County Adult Education.

As a part of its community outreach, Marion County Adult Education partnered with Palmetto Care Connections to host a digital literacy training for Licensed Practical Nursing (LPN) students between the ages of 20 to 48 years old attending the Marion County School of Practical Nursing. PCC created a workforce development curriculum to teach fundamental computer skills to support the students with their educational goals.

The success of this LPN training led to two additional digital literacy trainings at MCAE because of “word of mouth”. While the first training was focused on workforce development, the others centered around the general needs of beginners to thrive in a technology-based era.

Tracey has also enrolled in the Affordable Connectivity Program, one of the Federal Communications Commission's programs to help eligible households pay for internet service. By having internet and a laptop at home Tracey is one step closer to reaching her career goals to become a health care leader in the field of nursing.

Palmetto Care Connections (PCC) celebrated Telehealth Awareness Week, September 18-24, 2022, by hosting several community-based events. PCC partnered with a church, a senior center, and an affordable housing development complex, to host Telehealth Tech Talk with the Doc in Allendale, Bamberg, and Orangeburg counties reaching more than 60 community members. Telehealth Tech Talk with the Doc created an opportunity for community members to see a mock telehealth demonstration, talk with a local health care provider about telehealth, and learn about digital inclusion resources solutions such as the Affordable Connectivity Program and PCC's Digital Literacy Training.
